On behalf of the American College of Trust and Estate Counsel, we are pleased to announce the launch of the New England Fellows Institute. The institute is modeled after the successful Florida, Heart of America and Mid-Atlantic Fellows Institutes. These Institutes were formed to identify and develop future ACTEC Fellows through a series of in-depth presentations and social events. The in-depth presentations will be led by outstanding subject matter experts (primarily ACTEC Fellows), and the social events will be attended by ACTEC Fellows from the New England Region to expose the students to well-known ACTEC Fellows and the ACTEC Fellows to a new generation of potential future Fellows.

Candidates for the New England Fellows Institute will come from Maine, New Hampshire, Vermont, Massachusetts, Connecticut or Rhode Island. Each candidate must be nominated by an ACTEC Fellow during the nomination period, which will run from **February 14 through March 31**. Candidates must be members in good standing with the Bar Association in one of the founding states and must have at least three years of practice in the trust and estate field. Participants must successfully complete six programs (3 two-day sessions) to be recognized as Graduates. The schedule for the New England Inaugural Class includes the following dates:

**Session I:** Thursday and Friday, November 5 & 6, 2020

**Session II:** Thursday and Friday, February 11 & 12, 2021

**Session III:** Thursday and Friday, April 22 & 23, 2021

All three sessions will be held at the Boston Marriott Newton in Newton, MA.

Tuition for the Inaugural Class is offered at \$3,600 per student, which includes all programs, breakfast and lunch during each session, a dinner reception, and website access to course materials.
